Memorandum of Association (MOA)

1. Name of the Institution

The name of the institution is Orange City Institute of Management, Nagpur (hereinafter referred to as “the Institute”).

2. Registered Office / Location

Rui Village, Wardha Road, Nagpur, Maharashtra, India.

3. Founding Body / Sponsoring Trust

Established and governed under Jai Durga Bahu-Uddeshiya Jankalyan Sanstha, a registered trust/society under the Societies Registration Act, 1860 and the Bombay Public Trusts Act, 1950.

4. Objectives of the Institute

1. To impart quality management and business education to students at postgraduate levels.
2. To develop leadership, entrepreneurship, and innovation through research, training, and consultancy.
3. To promote industry-academia interaction through internships, corporate projects, and placements.
4. To contribute to social and economic development through community engagement, extension activities, and ethical practices.
5. To provide continuing education, certification, and executive training programs for professionals.

5. Affiliation

The Institute is affiliated to Rashtrasant Tukadoji Maharaj Nagpur University (RTMNU) and approved by the Directorate of Technical Education (DTE), Maharashtra, and AICTE, New Delhi.

6. Vision

To develop a world-class management institution which will provide technological and socio-economical development to society and impart leadership training with social sensitivity, human values, and skills of managing change.

7. Mission

9. Funds and Assets


All funds, grants, and endowments shall be utilized solely for the objectives of the Institute. No portion shall be distributed among members.

10. Amendments

The MOA or Rules may be amended by a two-thirds majority of the Governing Body, subject to approval of the Parent University and competent authorities.

Statutes / Rules & Regulations

1. **Admission Policy:** Admissions shall be made in accordance with AICTE, DTE and RTMNU guidelines.
2. **Faculty Recruitment:** As per AICTE norms and affiliating university qualifications.
3. **Courses Offered:** MBA which is AICTE-approved and university-affiliated program.
4. **Examinations:** Conducted as per RTMNU regulations.
5. **Student Discipline:** Students must adhere to institutional code of conduct and academic integrity.
6. **Financial Management:** Audited annually by a certified auditor; reports submitted to Trust and regulating authorities.
7. **Annual Report:** The Institute shall submit its annual academic and financial report to the parent trust and the regulating authorities.
